### **ADMISSION FEE**

Each student seeking admission to the B.A./B.Sc./B.Com./B.B.A)/B.C.A., under CBCS, shall be required to submit the prescribed application form alongwith requisite fee:

- For the first and second semester courses at the time of seeking admission to first semester;
- For the third and fourth semester courses at the time of seeking admission to the third semester; and
- For the fifth and sixth semester courses at the time of seeking admission to the
  fifth semester. Provided the student continues his/her studies without
  interruption from first semester to second semester, from third semester to
  fourth semester and from fifth to sixth semester. If there is a gap of one or
  more semesters he/she will have to fill up the prescribed application form and
  pay the fee at the time of seeking admission.
- © Fee Structure shall be as per latest fixation by the State Government and University of Jammu. Fee once paid is non-refundable.

# ADMISSION PROCEDURE

The date of admission to B.A/B.Sc./BCA/ B.Com Semester-I, III and V classes in the College shall be notified in accordance with the directive issued by the University of Jammu, Jammu.

Students seeking admission shall apply for Information Brochure Cum Admission Form available in the college on the cash payment of Rs. 50/-.

### **ADMISSION RULES**

- A candidate who has passed Higher Secondary Part- II Examination through J&K Board of School Education or an examination recognized as its equivalent by the University of Jammu is only eligible for admission to B.A, B.Sc. B.Com & B.C.A. Semester- I.
- ω Admission is open to all state subject holders and children of Central Government employees, Army and Para- military personnel posted in J&K State.
- ω A candidate who is admitted to the college and completes the minimum required attendance but either fails or does not appear in the university examination afterwards, will not be considered for admission in same class again.
- A candidate with a break in academic year will not be considered for admission in the college. However, Principal may allow gap cases subject to the availability of seats where he gets fully convinced by the time gap justifying reasons.
- ω Admission to a particular stream/subject combination shall be purely on the availability of seats. Change of subject & Stream is not permitted after admission.
- ω A student whose result is declared late by the Board/University may be admitted as per admission rules of the University subject to the availability of seats.

- ω All the students seeking admission shall have to be present themselves personally, along with their parents/guardians.
- ω Admission is based on the availability of seats in the combination concerned and merit in each category including reserved category such as SC/ST etc.
- ω Admission to various classes starts on the dates notified by University of Jammu.
- ω All drop out cases, absentees, re-appear and failure candidates shall not be admitted in any case.
- ω Candidates from other institution will not be admitted other than the exceptional cases (Not applicable for Semester-I).

### **CANCELLATION OF ADMISSION**

- If a student remains absent continuously for 15 days without any genuine reason/and information, his/her name shall be struck off from the College Roll and he/she will not be re-admitted under any circumstances.
- Any student found indulging in any undesirable activity in the College shall be dealt under rules to the extent of rustication from the college.
